Topic Original Report

M.O. By having concealed and readily available at hand, a concealed weapon, namely an 8 inch kitchen knife on her person.

On 9-29-2009, at 1623 hours, Ptl. Rebraca, Sgt. Favre and I were detailed to 1327 Bonnieview Ave., in response to a unwanted male in apartment # 412. Officers were told to meet the complainant in the leasing office apartment # 112.

Upon our arrival, officers talked with the complainant, COM/ TAMARA SWARTZENDRAUBER. While we were talking with TAMARA, her friend ARA/ MARILYN PENN was there offering support to her. When PENN went to leave the leasing office, Sgt. Favre noticed a wooden handle sticking out of the back waistband of her pants. When asked what she had in her pants, PENN produced the listed kitchen knife. When asked why she had the knife, PENN stated " I thought that I was going to have to do something stupid".

PENN was placed under arrest, handcuffed, and placed in the back of car # 209. PENN was issued citation # M43494 for Carrying a Concealed Weapon. PENN was transported back to LPD and booked in by Ptl. Eikens.

The listed knife was entered as evidence and placed in the locker # 16 of the property room.

PENN is BCI # [REDACTED] and has a criminal history including Felonious Assault, Domestic Violences, Endangering Children and Aggravated Burglary.

Topic Original Report

MO: By being voluntarily intoxicated, bloodshot/glassy eyes, slurred speech, swayed while standing, odor of an alcoholic beverage on her breath, verbally and physically fighting with her boyfriend.

Lt. Warner, Sir,

On October 8, 2009, at approximately 0140 hours, SGT. ESCHWEILER, INV. REGISTER, PTL. HAYES, and I were dispatched to 1327 Bonnieview #219, on a male and female fighting, with knives involved. We arrived, and COM/ KEVIN C. BALDWIN SR. stated that he and his girlfriend, ARA/ MARILYN PENN, had been drinking tonight, and got into an argument.

BALDWIN stated that they were arguing over sexual relations, that they had last night. BALDWIN stated that PENN was upset and yelling at him. BALDWIN stated that they each had a knife and swung at each other. BALDWIN stated that he cut PENN on the arm. BALDWIN stated that he was also cut on his arm, from PENN. There was a small, superficial cut on BALDWIN's right arm, near his wrist. PENN had a small cut on her left arm, but it was old, and had a scab on it.

PENN denied that either of them had a knife. PENN stated that they were arguing back and forth, and the kitchen chair got between them. PENN stated that BALDWIN was not cut at all, and she got the cut on her arm, from the chair.

PENN stated that BALDWIN had sexual relations with her last night. PENN at first stated, that she woke up in the middle of the intercourse, then retracted her statement, and stated that she did not know what had happened, because she was asleep. PENN stated that she went to the doctor's yesterday, because of the incident, then stated that she had an appointment with the doctor tomorrow. PENN stated that she needed to wait, because then the hospital care would be free. PENN stated that she went to Lakewood Hospital, then changed her story to Northcoast Hospital.

PENN was highly intoxicated. While I was speaking to PENN, she was attempting to stand up straight, and kept swaying. I also had a hard time understanding the words coming out of PENN's mouth, because she was slurring her words, and kept repeating herself, in the middle of a sentence. PENN had an odor of an alcoholic beverage on her breath. I asked PENN how much she had to drink tonight, and she stated, "Not a lot, a forty ounce and a twenty-four ounce."

PENN's inconsistencies with the time line, and what had happened, made it impossible for me to get a statement from her. I was unable to determine what had happened the night before. PENN brought up the sexual relations, because she wanted me to tell BALDWIN that he had to sleep on the couch tonight.

BALDWIN spoke with PTL. HAYES and INV. REGISTER. BALDWIN refused any further police involvement, regarding the knives. BALDWIN refused to give us a statement, and stated that he did not want to press charges against PENN.

INV. REGISTER collected the two, kitchen knives, for safekeeping. The small knife was laying on the couch, and the large knife was laying on the kitchen counter. INV. REGISTER was able to photograph the cut on BALDWIN's arm. PENN was arrested for DCI. I transported PENN to LPD,

where she was booked into jail by PTL. ROMANELLO and Dispatcher Komora. PENN was issued citation #M42735, for DCI, and advised of her court date.

INV. REGISTER tagged the knives into property, and placed them in locker #23. The knives were labeled with a biohazard label, (there was no visible blood on the knives).

BALDWIN has a CCH for Forgery, Receiving Stolen Property, Theft, Possession of Criminal Tools, Possession of Cocaine, Probation Violation, and Domestic Violence.

PENN has a CCH for Burglary, Felonious Assault, Aggravated Assault, Domestic Violence, and Endangering Children.
