Topic Original Report:

On 3/30/10, at approximately 2038 Hrs., officers were detailed to 1327 Bonnieview in reference to a welfare check. On our arrival, we spoke to COM/KERRI ANGEL who advised that she has not heard from her brother, SUB/FREDERICK ANGEL, since Fri. 3/26/10 at 1930 Hrs.

KERRI advised that when she spoke to FREDERICK he was somewhere on West Blvd. in Cleveland. KERRI stated that FREDERICK goes there when he is looking to buy drugs, specifically crack cocaine. KERRI said that it is not normal for FREDERICK to not come home the same day. KERRI advised that FREDERICK has never done this before. FREDERICK will usually smoke the drugs in his apartment, #402.

KERRI has been unable to contact FREDERICK and there is no answer at his apartment door. Maintenance from FREDERICK's apartment building was able to unlock FREDERICK's apartment so PO. GREEAR and I could check inside. FREDERICK was not in his apartment.

KERRI did not know what FREDERICK was last wearing, but was able to advise that he walks with a limp and a cane. KERRI advised that FREDERICK does not have any friends in the area. FREDERICK does not suffer from any mental illnesses. KERRI also advised that FREDERICK does not own a car.

KERRI said that FREDERICK's mother is very ill and lives in Youngstown. KERRI had called her mother's nurses and friends and family who live there to find out if FREDERICK was in Youngstown. KERRI advised that FREDERICK was last seen in Youngstown 2 weeks ago when he was there with her.

The local hospitals and jails were checked for FREDERICK with negative results.

Dispatcher Sykora entered FREDERICK as missing at 2138 Hrs., with NCIC M358663793 and State ID MX05325940.

There was only a BMV photo of FREDERICK available. It was forwarded with this report.
