

Original Report

M.O.- By having 3 hypodermic needles in her purse, without any lawful reason to do so.
M.O.- By having Suboxone in her possession, a schedule III drug.

On 10/18/10, at approximately 1935 Hrs, officers were dispatched to 1327 Bonnieview on the report of a Baker Motor's driver having difficulties with someone.

Upon our arrival COM/JEFFREY D. MERDITH and ARA/SARAH A. MALEC were settling on a dead run. We spoke with MERDITH, and he advised that he had his dispatch contact us because while MALEC went in her purse to grab something, he saw some needles in it, and he was worried she was on something. He stated that his business with MALEC was completed, and he needed nothing further from us.

I spoke with MALEC, and she advised that she is on no prescription medications and does not use needles for anything. MALEC's hands were shaking, and she was extremely lethargic when she spoke. I asked MALEC if she had anything with her that she should not have, and she stated that she did not. MALEC then stated that officers could check her. She began to empty her purse, and I asked if I could check it. She handed the purse to me and said I could. Upon opening her purse MALEC stated that there was some SUBOXONE in it. Inside the purse I located 3 hypodermic needles and a small clear vial with part of a pill in it. MALEC was arrested and secured in the back of unit 215.

The pill in the vial was orange and appeared to have originally been a hexagon in shape. Upon checking with a pill database, the pill appeared to match SUBOXONE 8mg pills. SUBOXONE is a schedule III controlled substance.

MALEC was advised she was being arrested for possession of hypodermics and drug abuse. The vehicle was towed incident to arrest by Baker Motors. MALEC was transported to the Lakewood Jail, and was booked in by CO SMITH and DISP SYKORA. DISP SYKORA conducted a strip search of MALEC, but no further contraband was found. MALEC was issued citations M45908 for possession of hypodermics and M45907 for drug abuse.

The needles and pill were tagged as evidence and placed in the drug chute of the Lakewood Property room.
